

The Janette Garlock Miller, MS, RN Nursing Scholarship Endowment has been established at the Upstate Foundation by an alum who is grateful for the opportunities Upstate presented to her through the years and wishes to give back.

Following graduation from a high school in rural Herkimer County, Janette Garlock Miller headed off to Syracuse to attend Upstate's College of Nursing on a Nursing Regents scholarship. It was 1971 and Janette had never even been in a hospital. The young nursing student also never dreamed that would be the start of a 52-year career at Upstate University Hospital.

In 1984, she returned to the College of Nursing to receive a master's degree with a focus on Clinical Nurse Specialist and Nurse Practitioner.

"The opportunities at Upstate have been endless," Janette smiles and shares. "I have received so much from Upstate, and I am very appreciative. I felt I had to give back."

She added, "I know how much it costs to get these degrees. I worked the entire time I was going through school. I want to help those who follow behind me."

gift you will be eligible to make to the Upstate Foundation will be determined by the amount of interest the tax credit program receives. The great benefit of this program is that unlike a standard donation to a charity, which may be used as a deduction, the gift to the Upstate Foundation will receive a tax benefit in the form of a credit of 85 percent of the donation to be used against your New York state tax liability. If you are typically in a position where you have a bottom-line tax liability with New York state, this program can be extremely beneficial in recouping some

of that liability, while still allowing you to donate to an extremely worthy cause. Consult with your tax preparer or representative at the Upstate Foundation today for more details.
